Other forms of notice are not sufficient. The effective date of the cancellation is the date we receive the written cancellation notice. A name change or substitution of participant is also treated as a cancellation in that all cancellation charges apply. Cancellation charges are per-person, based on the cancellation date, as follows: 89-60 days before departure: 35% of cruise and land price; 59-30 days before departure: 50% of cruise and land price; 29-7 days before departure: 80% of cruise and land price; 6 days or less before departure: 100% of cruise and land price. Deposits vary, please check with your travel agent. Protection plan premiums are non-refundable. After travel begins, there is no refund for unused services, or unused portions of cruise, cruise/tour or airfare.

**PASSPORT AND VISAS:** A valid passport is required for each participant. Passports must be valid for at least six (6) months after the scheduled return date to the USA. For travel to Vietnam and Cambodia, we require a copy of your valid passport prior to or at final payment. If not received in this time, embarkation may be denied and cancellation penalties will apply. For travel to Africa, a valid passport with 8 open/non-stamped pages is required. At publication time, a visa is required for a US citizen to travel to Russia, Turkey, Vietnam, Cambodia, Kenya, Tanzania and Zimbabwe (as well as numerous other countries). A non-US citizen must consult appropriate consulates regarding visa and other document requirements. 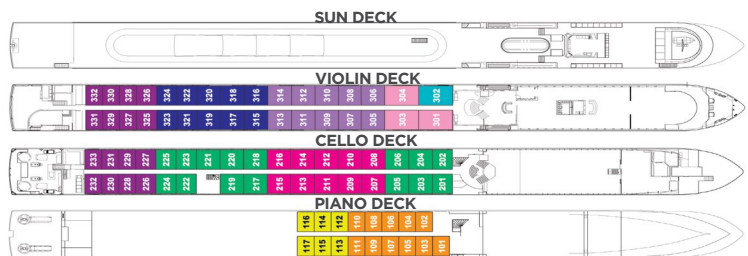
